<u>Self-Advocates Participate in OADS Listening Sessions</u>

Self-advocates from all over the state have been working hard to prepare testimony to share at the Virtual Listening Sessions hosted by the Office of Aging and Disability Services. These listening sessions have been centered around 14-197 C.M.R. Chapter 5, Regulations Governing Behavioral Support, Modification and Management for People with Intellectual Disabilities or Autism in Maine.

Self-Advocates worked with Disability Rights Maine to prepare their statements to share how the use of restraints affect them and others who live with disabilities. There is one final listening session on April 30th from 3-5 pm. For more information on that please go

I like working with Kile and how he can mentor me on certain topics when we work together.




Kick off To Advocacy Day
