A DRAFT BILL WAS UNVEILED IN APRIL KNOWN AS THE HCBS ACCESS ACT













- IT WILL REQUIRE MEDICAID TO PROVIDE HOME-AND COMMUNITY-BASED SERVICES TO EVERYONE WHO IS ELIGIBLE.
- ESTABLISH A MINIMUM NUMBER OF SERVICES THAT STATES MUST OFFER.
- ELIMINATE WAITING LISTS.

A SUCCESSFUL HCBS PROGRAM MUST



- Pay people with disabilities minimum wage or pay depending on peers within the same position.
- Inform members of the options for individualized support.
- Allow individual to set their own support schedule.

THE BILL IS DESIGNED TO HELP STATES CREATE A NETWORK OF PROVIDERS AND WORKERS TO DELIVER SUPPORTS

- Build support networks to include financial brokers, community liaisons, direct support, caseworkers, and providers for nonmedical transportation.
- Broaden eligibility requirements.
- A committee panel that includes people with disabilities.
- Establish network quality.
- Money Follows the Person (MFP) program.
- Eliminate the wait list to create access to all services in all areas.

Washington, March 16, 2021

WASHINGTON, D.C. – Congresswoman Debbie Dingell (D-MI), Senator Maggie Hassan (D-NH), Senator Bob Casey (D-PA), and Senator Sherrod Brown (D-OH) today released a discussion draft of the HCBS Access Act for stakeholder feedback. The proposal seeks to mandate HCBS in Medicaid to provide critical services, creating national, minimum requirements for home and community-based services, and make it possible to enhance those services and the long-term care workforce. 
