Bangor, Greater Portland, Casco, and Springvale have all been talking about the same things in their chapters. Some of the highlights have been a training on using coping skills when we find ourselves in those triggering situations. In addition, we talked about how to figure out which ones work best for each of us, and how to communicate that to our staff and supporters.

Our most recent, and requested training was on getting back to life after the pandemic. As many of the restrictions are being lifted and we are able to go out and meet with each other we wanted to talk about how to navigate those social situations. For some of us there was the realization that maybe we aren't ready for that yet, or maybe we don't want things to return to the way things were. We get the opportunity to define our future and what and who takes up our time. We spent time in each chapter learning about how to set boundaries on what social situations we want to be part of, how to ask questions about social events, and communicate what we were comfortable with.

Last week I was able to attend a Public Speaking workshop. It showed us how to prepare for public speaking. They talked to us on how to dress for speaking to the public, and how to be positive. We were able to educate Pine Tree Legal Assistance on the history of Self-Advocacy in the State of Maine. We were able to talk about Maine's institutions closing.
